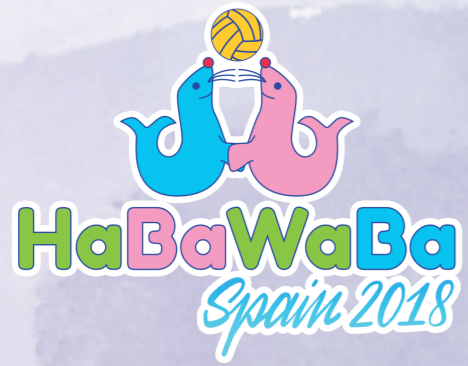

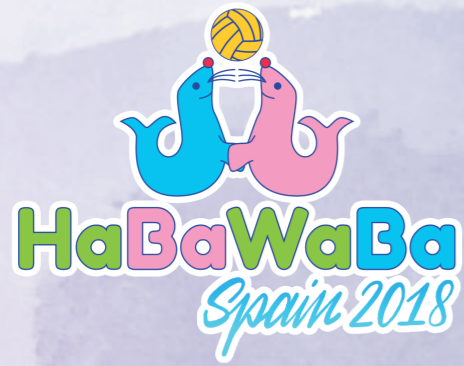

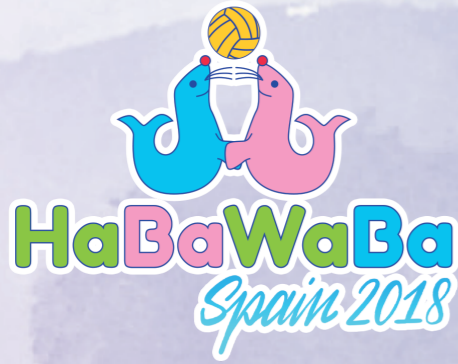

AUTHORIZATIONS AND IMAGE RIGHTS

The signee, guardian of a minor, with exclusive responsibility and in knowledge of the Organic Law 15/1999 of 1 December, is aware that the personal data collected by BIWPA SL is treated in accordance with said law and declares that:

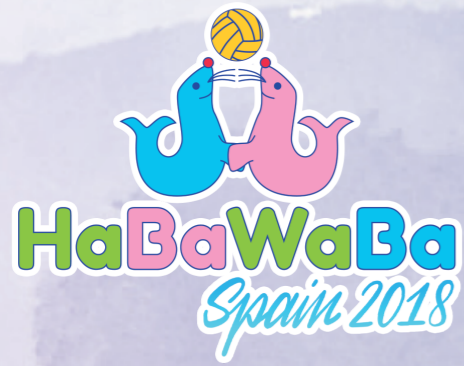
1. I am the legal guardian and I have the parental responsibility of the junior athlete who will participate in HaBaWaBa Spain 2018.
2. The minor athlete is in perfect physical and mental condition and as their guardian, I have the responsibility to inform the organizer if during the event their health condition deteriorates and it does not allow them to participate in sport activities.
3. I am aware that the minor athlete's responsibility for care and protection lies exclusively with the Club's companions, who know and accept this. I accept that the BIWPA organizer has no responsibility for athlete injuries, damages to the hotel or facilities during the event that could occur due to actions or negligence of the minor athlete. In that case, I will assume

the responsibility to restore the damages and / or pay any compensation that may occur. For the minor, the coaches and the chaperones of the team are responsible, since they have been appointed by the club president, who confirms and approves the validity of this document with their signature.

4. With my signature, I authorize BIWPA the use and exclusive exploitation of images, photos and videos made during the event and / or its secondary activities in cooperation with other organizations. The use of the images mentioned above, photos and videos, in a way that insults the personal dignity and decency of the people photographed in them are strongly prohibited. The use, promotion and exhibition of photography and video is free and the exclusive right of use belongs to BIWPA, which may assign them to their official partners without prior authorization and / or approval.
5. I declare that all athletes who are members of the registered team are registered with the Club and have a federal license that entitles

them to medical coverage in case of injury during the event.

6. I declare that BIWPA reserves the right to exclude individual athletes or the entire team if some of the conditions or terms are not respected.
7. For any conflict related to HaBaWaBa Spain 2018, the validity of interpretation and effect of this document between BIWPA and / or participants in HaBaWaBa Spain (athletes, team leaders, family members and guardians, such as damages to persons and / or properties within the accommodation and facilities of the event, but not limited to that), it will be the Spanish courts and the law that have exclusive jurisdiction.

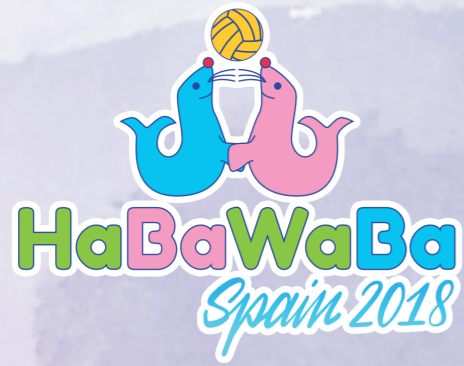
